### Review Policy Committee Workplan

Mr. Hoying reviewed the Workplan with the Committee group and reported that the Committee will continue use of the Workplan. The Committee will continue its review of the policies, beginning with series 5000 – Students.

**ACTION:** The Policy Committee agreed with continued use of the Workplan and review of the policies on a three-year rotation. The Committee will recommended to the Board approval of the Workplan (copy attached) for year 2019, at the January 28, 2019 Business meeting.

### Continued Review of Series 2000 – Program Policies

#### ACTIONS:

- **Policy 2210 – Curriculum Development** – Committee Chair Davis and Board member Bolton will review the policy and discuss their recommendations at the February 21, 2019 Policy Committee meeting.
- **Policy – 2261.01 Parent Participation in Federal Programs** – Mr. Hoying recommended no amendments to the policy. The Committee will review this policy in conjunction with new Policy 9145 – Internal Communications and Engagement.
- **Policy 2412 – Homebound Instruction Program** – Ms. Addo reported that she met with Curriculum and Student Services and recommended no changes to the policy. The Policy Committee advised that language regarding referrals to the Cincinnati Digital Academy and Virtual High School need to be included in the policy for Homebound Students. The Committee will recommend to the Board approval of the policy at a Business meeting.

- **New Policy 9145– Internal Communications and Engagement** – Mr. Hoying reviewed amendments to the policy. The Committee will review suggested changes to the document at the February 21, 2019 Policy Committee meeting.

**Review of Policies: Local Vendor and Minority Women Businesses (Good Food Purchasing Program)**

Mr. Hoying and Ms. Levins reviewed and discussed with the Committee the following policies relating to contracting with Local Vendors and Minority and Women Owned Businesses.

- 6320 – Purchasing Goods and Services
- 63201.01 – Lowest Responsible Bidder
- 6320.02 – Business Policy

He also reviewed the Board’s *Resolution on Equal and Fair Opportunity in Contract Employment and Business Opportunities* with the group. Mr. Hoying will update the resolution to current standards and equal opportunity goals.

**ACTION:** The Committee assigned Mr. Hoying to update the below Exhibit A that is contained in the resolution and revise the goals, based on the City’s [2015 Disparity Study](#) to ensure they are legal for minority and women participation. Language about regular reporting from the businesses will be included in the policy.

**Exhibit A  
Provisional Contractor Employment Goals  
for Minorities and Women\***

Trade	Goal
All Construction Trades	20 percent, based on Board Resolution April 28, 2003 to be reasonably attained by means of applying good faith efforts.
All Other Occupations	Targets, to be determined by CPS administration, reasonably attainable by means of applying good faith efforts.

\*Note: The Cincinnati Public Schools will update the above goals periodically, based on factual availability determinations. These employment goals will be used as a partial basis in determining Bidder’s responsibility, except that the failure of Bidder to comply with this requirement shall not be the sole basis of the rejection of a Bidder as not responsible.

The Committee reviewed a draft of *A Resolution to Adopt the Good Food Purchasing Policy*. The Policy Committee advised the Administration to make sure attention is paid to minority workforce and the District’s procurement practices.

**ACTION:** The Committee will recommend approval of the Good Food Purchasing Policy Resolution at the January 28, 2019 Business meeting.

Mrs. Shelly provided the Committee with a copy a Good Food Purchasing Policy that was adopted by the Oakland Unified School District in California.

ACTION: Mrs. Shelly will discuss a draft of a policy for the District at the February 21, 2018 Policy Committee meeting.

**Update on Rental of Athletic Facilities Policies (Walnut Hills Swimming Pool)**

Mr. Hoying updated the Committee concerning the complaint Committee member Bates received from a constituent about the perception that the Administration is giving priority for the use of the Walnut Hills High School swimming pool to private swim programs, requiring the Clark Montessori swim team to use the pool at the Norwood YMCA for team practices.

Mr. Hoying reported that Clark was using the pool at the Melrose YMCA, until it no longer became available. Clark reached out to Walnut for use of their pool and learned that it was contracted out to a private swim team through the end of the year. Clark is now practicing at the Norwood High School, the YMCA, and at Walnut on Saturdays. The Committee advised Mr. Hoying to make sure that Walnut gives CPS students priority over use of the pool.
